**CORPORATE PARTNER MEMBERSHIP (Non-Voting)**

Corporate partner memberships are available to accommodate commercial or private individuals and outside corporate organizations who wish to be affiliated with and support the Central Florida Fire Chiefs' Association's mission. Membership criteria shall be an organization or individual who would benefit the Association, or who would be directly related to the fire/emergency medical service where a close association would be beneficial to both parties, i.e., alarm companies, sprinkler companies, apparatus manufacturers, service or equipment vendors and other associations with similar goals in public safety and fire/rescue.
